# USC Lancaster Faculty Meeting Minutes November 1, 2024

**CALL TO ORDER**: 12:30 PM Dana Lawrence

**CORRECTION/APPROVAL OF MINUTES**: The minutes of the October 4, 2024, faculty organization meeting were approved.

Dean of the Campus – Dr. Courtney Catledge, report submitted (Appendix 1).

- Highlights from report:
  - Enrollment has dropped slightly due to non-payment
  - o Staff search (Dir. Outreach and coordinator of IL campus)
  - Athletics update: Things are going well; thanks to those who showed up for the send-off to Women's soccer; Volleyball has a big match coming up; Awards (see her report for the many instances)

#### Questions and/or Comments:

N. Lawrence – Are there any updates to the policies about free speech zones?

C. Catledge – Yes, I have spoken with Palmetto College administration who shared Columbia's campus policies, asking us to review and make recommendations to update/adapt for our campus. Todd Lekan and I have been making possible edits to make it fit Lancaster. They hope to offer an ad hoc committee to advise on content before sending recommendations back to Central. Then we will adopt the final policy for our campus. We want a unified approach that reflects our campus.

N. Lawrence – What is the current policy while that work is being done?

- C. Catledge There is not really a campus policy posted anywhere. We will adhere to our student handbook if there are disruptive behavior/activities, as with any other activity/location, but we will not seek out or relocate people who are demonstrating within those parameters. It is worth noting that Columbia campus policy requires registration and sticking to a specific determined location (for documentation purposes) and if people come on campus without approval, they are referred to the office for registration.
- P. Lawrence (in chat) Can I volunteer for that committee? (And other questions related to volunteering/appointments to the ad hoc freedom of speech committee)
- C. Catledge and T. Lekan We do not want to appoint people to that committee, so consider this conversation a call for volunteers (an email will follow). The ad hoc committee will be open to any faculty or staff (likely all who work here plus student rep(s)

Associate Dean for Academic and Student Affairs – Dr. Todd Lekan, report submitted (Appendix 2).

- J. Castiglia How were the four [Winter session] courses being piloted determined?
- T. Lekan We examined what would be most useful to our students and compared to what other system campuses are offering
- J. Castiglia What classes are they?
- T. Lekan Psychology, Sociology, Political Science, and History

- C. Heinemann-Priest (in chat) So Columbia is cutting one Summer Session to 11 days
- T. Lekan They set this based on instruction minutes
- E. Nooe (in chat) On travel: should be still fill out a travel authorization if we do not plan to request reimbursement?
- T. Lekan You should always fill out a TA when traveling on university business regardless of whether you are requesting money. Discussion followed about individual campus policies and rationale behind this policy. USC Lancaster faculty should send travel authorizations when traveling on university business and contact Karin Collins with any questions.
- S. Criswell Re: Shorter summer sessions and Claudia's comment--Any chance we can keep the per class enrolment low for courses like ENGL 101 and 102?
- T. Lekan Whatever we did last summer about capping classes should still be in place.

- Draft of post-tenure review procedures nearly finished and hope to bring motion to the faculty in December
- The Senate is working on multiple charges to standardize procedures across Palmetto Campuses. We want to examine our policies in advance before these charges turn into motions

#### Questions and/or Comments:

- N. Lawrence Could you elaborate on what you called "overly aggressive stance on standardization" (in your report)?
- C. Bundrick Clarified that his report used that phrase "in case" it happened. He shared examples of multiple charges from recordings of the senate meeting and emphasized the importance of establishing substantive, clear language before discussions break out.
- B. Taylor-Driggers offered context for the R&R committee charge, stating that some of these charges are left over from previous year's business. The Palmetto College manual does note that these processes are handled by each campus. She encouraged faculty to share comments and concerns with her to convey to the committee.
- J. Yarosh Comment that Brittany's request for feedback to share with R&R also goes for System Affairs, faculty can share feedback, and he is happy to share
- N. Lawrence What is the reasoning behind these questions [about standardization between the PC manual and campus policies]?
- B. Taylor-Driggers These concerns reflect concerns on other campuses because there are some things outlined in local policies but not covered in the PC manual.

Discussion followed about individual campus culture/attitudes towards local policies compared to the PC manual and its appendices.

Hiring Priorities Committee – Written Report (Appendix 12)

#### Questions and/or Comments:

- S. Penuel Question about the written report: We are hiring a social sciences position with a position description noting that it was heavily dual-enrollment but not limited to dual enrollment. How is this different from a regular faculty position?
- T. Scarlett We advertised the position as a social sciences instructor with specialties in those areas [Psychology, Sociology, Criminal Justice], but were being upfront that there will be a great deal of Dual Enrollment teaching, even if it is not strictly a Dual Enrollment-limited position
- S. Penuel Since many of our faculty teach a majority Dual Enrollment student body, how is that different?
- T. Scarlett Fundamentally, it is not different, but it was structured based on the high demand specifically for the DE classes

Discussion about the specifics of this position description and limitations of instruction to only dual-enrollment students in the high schools, implications of setting up a two-track system of dual-enrollment versus traditional instruction, disclosure of high demand for instructors of record to teach at the high schools.

- C. Jones Question about Computer Science position focusing on 101 and 102.
- T. Scarlett Demand for higher level classes has gone down due to math placements; we don't want to get to a position where we *can't* teach a higher level, but the demand has gone down to the 101 and 102 level.

# REPORT TO THE FACULTY ORGANIZATION November 1, 2024

- 1. Open House. Last Saturday we held a successful open house on campus for prospective students. Thanks to Ms. Aubrey Stewart., the admissions team, USCL students, and faculty for participating in this important recruiting event.
- **2.** Last Day to Withdraw. Wednesday, November 6 is the last day for students to withdraw with a W from the 16-week semester. Before this day, please have conversations with students who are in academic trouble, encouraging them to reach out to their advisors for guidance.
- 3. Winter Session. We are piloting winter session courses. Winter sessions may help students who need hours for financial aid and scholarships, early graduation, alleviate their course load in the spring, boost their GPA, and more. Note that "winter session" counts as part of the spring term for student course loads. Winter session runs from December 30-January 19. Students are restricted to one of four possible courses. If they wish to register for more than one winter session course, they may seek approval from The Associate Dean by December 19th.
- **4. Summer Terms**. We have had to adjust the class time and date periods to align with Columbia's schedule and to handle the later start dates. Please see the calendar at the end of this document for examples of these times in three summer sessions. Many thanks to Megan Catoe and Pamela Ellis for working diligently to ensure we comply with USC's requirements.
- **5. Faculty Travel Requests.** Thank you for submitting your travel requests. The current form asks faculty to prioritize multiple requests and, if possible, to submit requests by November 15. As we get close to November 15, the Division Chairs and I will review the budget for those requests submitted but not yet approved. It has been brought to my attention that in the past—perhaps prior to 2020--travel funds were only awarded for faculty presenting at conferences. Our current policy allows for 80 percent of trip funding for attendance without presentation. The form can be found here:

## Recent and Upcoming Events Overview

In October, the ASC held three additional review sessions for nursing subjects (BIOL 243 and NURS 216) as part of our Health Sciences Studio service. Peer-tutors Caysen Horton and Kennedy Bumbrey led these sessions as usual, and they were attended by 22 students in total.

Two Medford Library toolkit talks were held in the ASC Studio in October, one about navigating Blackboard facilitated by Prof. McKenzie Lemhouse and one about nutrition facilitated by Dr. Liz Easley. We love to collaborate with other campus entities to provide student-focused programming, so please inquire if you have an event or program that might make sense in the Studio.

The ASC is in the early planning stages for a repotting party during finals week. The more than fifteen live plants in the Studio need new pots, and we would like to invite students to help us repot them and maybe a plant of their own to take home. We think this hands-on experience might help with the stress of finals, as well as helping us ensure our green friends can keep on brightening up the Studio.

# **Summary of Tutoring Data**

**Year-to-year trends:** At 144 sessions, the ASC was roughly as busy as in September, even with fall break meaning we were open fewer days. However, as the chart below shows, we were exceptionally busy at this time last year. The year-over-year decline appears not to be driven by any specific event, and it is worth noting that we are still up more than 75% over this time in 2022. We will continue to step up promotion on campus to ensure we're using our resources efficiently and growing sustainably.

**Session distribution trends:** Session distribution again reflects a high number of students in Studio services and steady interest in virtual tutoring. Use of ASC services by athletes (7%) and dual-enrollment students (4%) looks pretty consistent in October compared to September, though we did see a small jump in athlete visits. Course distributions were also typical, with the largest share in STEM, especially both versions of Math 111 and various CHEM courses.



This is a credit students get for rehearsing and performing in a production; specifically the spring musical Percy Jackson and the Lightning Thief. We will be rehearsing T, TH afternoons from 4-7 until the tech week in April where they need to be at the theatre for production preparation from Sunday to Sunday. I often have students add this course after they audition.

#### **THEA 170**

Introduction to the art and craft of acting. Practical exploration through improvisation and scripted scene work. Includes a brief history of the development of modern acting techniques. FS: 12/03/2014. CL: 2020

This meets the AIU requirement and works on the actor's craft working on various techniques from Stanisvlaski to Stasberg to Demidov, Meyerhold, Hagen, Adler, and many others. We do monologues and scene work.

#### **THEA 520**

#### THE UNIVERSITY OF SOUTH CAROLINA FACULTY SENATE

Wednesday, October 9, 2024
This session was held in person at the Russell House Theatre
PRESIDING CHAIR WAYNE OUTTEN
Chair Wayne Outten called the meeting to order at 3:00pm EST.

#### **Report from the President**

Following the Call to Order and approval of September 11 minutes, Dr. Amiridis discussed the Master plan for the USC Campus. 9 main projects totaling at least \$25-\$30 million were approved:

- 1. New medical school to be completed by Summer of 2027
- 2. Brain Health Center to be completed by Summer of 2026
- 3. Updated classrooms and labs to be completed by Fall of 2025
- 4. Renovation of Thomas Cooper Library to create more open spaces for students and remove some books there has been an 85% decrease in the number of students requesting books in the past 10 years.
- 5. Renovation of Jones Physical Science building
- 6. Removal of McBride dormitory to build new dormitory
- 7. Renovation of Russell House to move bookstore and create more kitchens in Dining area
- 8. Renovation of Barnwell and McKissick to revitalize center of University

There is also a plan to hire at least 50 new faculty members. The President addressed the on-campus event sponsored by Uncensored America on September 18, 2024 at the Russell House. The Student Senate agreed to fund the event, which featured Milo Yiannopoulos and Gavin McInnes. Uncensored America has filed a lawsuit against the University of South Carolina, but no specific individuals were named in the lawsuit. Dr. Amiridis stated he was unable to comment further about the incident or lawsuit.

#### **Report from the Provost**

Dr. Arnett emphasized the need for understanding and compassion in the wake of Hurricane Helene, as campuses and students were affected by the storm. She reported that the U.S. News Rankings Task Force had ranked USC #1 in International Business and New Student Experiences. #4 in Living and Learning Communities, and #61 overall. She stated the priority of the Provost's Office is a 94% retention rate for students. The current rate is 92%. She discussed nominations for faculty awards, which are due by November 11, and upcoming professional development opportunities and stressed the need to prevent burnout. She also mentioned a new evaluation program that will be integrated into Ultra.

#### **Report from Director of Parking Services**

Brian Faveta introduced himself and gave a presentation from Parking Services. The PDF of the presentation is on the Faculty Senate website. He discussed ways he intends to improve communication from Parking to the campus, including a bi-weekly newsletter, social media, and direct emails. He is also working to improve training for ParaTransit to shorten waiting time to less than ten minutes. There are plans to create a Smart Parking Campus containing a parking guidance system to integrate into the

ParkUSC app and provide red and green visual notifications of parking spaces. The goal is to integrate the app where drivers will know where the available parking spots are on campus.

#### **Update from Student Government on Mental Health Absence Pilot Study**

Dalton Byers from Student Government gave the update on the study, which allows excused absences for student mental health. Byers stated that Professors still have a right to deny excusing these absences, but students are hurting and need leniency. Byers stated that this policy would show the students that faculty members care about their mental health. He stated that students did not feel the campus cared and was passionate about their mental health. He stated that he was concerned about labs and other accreditation programs, but there was a goal to be proactive and provide resources. He referenced the UNC model to address concerns.

#### **Reports of Faculty Standing Committees**

Committee on Courses and Curricula report was accepted. This report contains course changes and inactivations to go into effect Fall 2025 and new courses and changes to course modality which go into effect Spring of 2025. Program changes effective Fall 2025 were also presented. In total, there were 7 proposals from the College of Arts and Sciences and 1 from the Molinaroli College of Engineering and Computing. A complete listing of the proposals is available on the Faculty Senate website.

#### **Report of the Chair**

The chair reported that changes to the faculty are forthcoming and will be presented at a future meeting for discussion.

#### **Potential Hires**

<u>Statistics</u> – Sue Mazzulo has taken a new position elsewhere. A search for an instructor or tenure track position has begun. The committee supports this hire.

<u>Computer Science</u> – This has been a position of concern for several years. CSCE 101 and 102 courses taught by Drs. Bohonak and Currence have very high enrollments. Also, Dr. Bohonak has taught courses needed by computer science and engineering students for a long time, though the need for these courses is declining because students are not placing well in math and leave the campus before they have the math prerequisites to take the computer classes they need.

Given the high enrollment in 101 and 102, we need someone to teach these courses as Drs. Bohonak and Currence are close to retirement. Several searches have been conducted, but we've not been able to hire anyone, largely due to the discrepancy between the salary we are able to offer and the salary a PhD or even an MS can earn elsewhere. The last search we conducted for this position was in 2019. The committee recommends that we conduct another search for a computer scientist at the tenure-track or instructor rank. Regarding a possible instructor hire, we suggest that contact be made with the computer science department in Columbia to see if they would approve an MS with 18 grad hours in computer science since these approvals can change as department chairs turn over.

<u>Nursing</u> – Dean Catledge is developing a cooperative relationship with MUSC to bring nurses who need continuing education credits and nursing and medical residents who need simulation training to USCL to more fully utilize Nursing Simulation Lab. As this program develops, we will need a full-time Simulation Lab Facilitator. Dean Catledge expects this to be a staff position and believes we will need this position filled by August 2025.

<u>PSYC 101 and SOCY 101</u> – PSYC 101 and SOCY 101 are in high demand for dual enrollment students. Dr. Neal (Division Chair) suggests we need a full-time dual enrollment instructor that could cover two of the following subjects: CRJU, PSYC and SOCY. Dean Lekan agrees with the proposal. Though it won't be advertised as a DE position teaching only HS students, applicants will be informed that much, if not all, of their load will be DE.

Local Tenure and Promotion Committee Report to Faculty

#### November 1, 2024

With November now upon us, we have a point of information to share regarding third-year review protocol. We also have an important development to report to faculty with respect to files for third-year review, post-tenure review, tenure and promotion, and promotion to full professor.

- 1. Third Year Review Protocol: The process for these files is set in motion by Jean Carrano, who receives candidates' files as well as summary of teaching evaluation letters for those candidates, and then places them in a portal for T&P committee members to access. After committee members access a file, they discuss it and write narratives about it. Once this is completed, the T&P Chair collates those narratives and into one document and then emails it to the candidate, copying Todd Lekan on the email as well. Because we are unsure if this process has ever been explicitly reported to the faculty, we thought it would be good to have written down somewhere (in the form of this report), and perhaps especially helpful to future T&P committee members and chairs.
- 2. Timeline Extension for Candidates' files, summary of teaching evaluation writers, and voters: On the afternoon on Friday, Oct. 4, in the wake of Hurricane Helene, all candidates and T&P committee chairs received the following note from Jean Carrano:

3rd Year Review and Tenure & Promotion Candidates,

In collaboration with the Palmetto College administration and Faculty Senate leadership, and in light of the impact of Hurricane Helene, we have decided to offer a two-week extension for your file submission, with a new deadline of November 15th.

Carrano later confirmed for me that this extension applies to summary of teaching evaluation writers as well. This also means that local T&P committees now have until **December 15** to finalize their ballots for Tenure and Promotion to Full Files. I presume that administrators and system level voters will similarly get two-week extensions, but I am unsure about this. Our local T&P committee included Post-Tenure Review Candidates as beneficiaries of this extension as well.
